What is this product?

Type: Shares of a Sub-Fund of Fund Channel Investment Partners, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: To exploit attractive return opportunities while keeping the level of risk under control by investing in selected equities of various European countries and sectors. The sub-fund invests mainly in equity or equity-linked instruments (including up to 10% of its assets in ADR/GDR) of large companies that are based in, or do most of their business in Europe. The sub-fund may also invest up to 10% of its assets (directly or indirectly via units/shares of UCITS) in small or mid cap companies that are based in, or do most of their business in in the same countries. The sub-fund may also invest in up to 10% in closed-ended REITS. The sub-fund may also hold cash or cash equivalent instruments on an ancillary basis. If the investment manager considers this to be in the best interest of the shareholders, on a temporary basis and for defensive purposes, the sub-fund may also hold up to 100% of its net assets in liquidities as among others cash deposits, money market UCITS (within the below-mentioned 10% limit) and money market instruments. The sub-fund may invest up to 10% of its assets in units/shares of UCITS. MSCI Europe (net div. reinvested). The sub-fund is actively managed by reference to and seeks to outperform the benchmark. The sub-fund is mainly exposed to the issuers of the benchmark, however, the management of the sub-fund is discretionary, and will be exposed to issuers not included in the benchmark. The sub-fund monitors risk exposure in relation to the Benchmark however the extent of deviation from the benchmark is expected to be significant. The investment manager selects companies of which the portfolio is constituted on the basis of criteria such as their environmental profile, an above-average commitment to social and environmental issues compared to other firms and a distinct corporate governance approach. The sub-fund does not invest directly in companies generating a substantial part of their revenues from the production of tobacco, adult entertainment, coal or energy from coal-fired power stations. The sub-fund's sustainability profile is based on the sum of all individual investments. The objective of the investment process is to select companies with an appropriate environmental profile, an above-average commitment to social and environmental issues versus other firms, and a more progressive corporate governance approach. The fundamental analysis of sustainability/ESG criteria may include various aspects of a company, such as its carbon footprint, employee health and well-being, management of the value chain, equitable treatment of clients and governance procedures.
