Objective and Investment Policy

Sub-Fund Objective

The Investment Objective of the Sub-Fund is to invest in a diversified portfolio of Green Bonds as suitable investment opportunities arise over the course of the Investment Period. Green Bonds are defined as debt securities and instruments issued by financial institutions active in emerging markets, the proceeds of which fund eligible projects meeting the criteria and guidelines of the Green Bond Principles, as determined by the Portfolio Manager.

From the Initial Closing Date, the Sub-Fund will invest in an initial portfolio comprising (i) Green Bonds, (ii) other Debt Securities and Instruments issued by financial institutions active in emerging markets, subject to applicable screenings under the Fund's ESG Policy, and (iii) quasi-sovereign and sovereign Debt Securities and Instruments, in each case, of issuers located in emerging markets (securities described under (ii) and (iii) above being together the "Other Bonds"). The Sub-Fund will seek to be invested in a portfolio comprising 100% of Green Bonds by the end of the Investment Period.

Mission statement and background

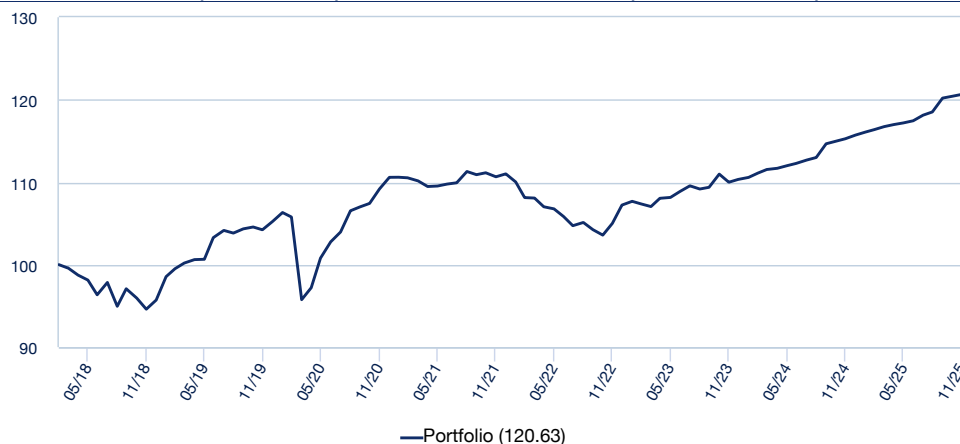
The Fund is a layered capital fund formed by Amundi to invest in Green Bonds and promote the issuance of Green Bonds. The layered capital structure has been designed to raise capital from private investors by building a risk cushion funded by public investors, development finance institutions and international financial institutions.

Amundi Planet - Emerging Green One is part of a program set up with development finance institutions seeking to promote and accelerate capital market development in emerging markets while trying to achieve various environmental and social goals in such markets.

In that respect, an Investment Support Facility has been set up, it is intended to assist in the development of the Green Bond market in Emerging Markets, by among others things, assisting issuers of Green Bonds to meet the Green Bond Principles, assisting in the dissemination of best practices in environmental, social and governance investments in target emerging countries and potentially organising events and training programs relating to Green Bonds.

Corporate & High Yield Debt**Management commentary****Part I: Market Commentary**

In November, EM debt was supported by a constructive global macro backdrop, broad-based disinflation and improving liquidity expectations.

US monetary-policy pricing and long-end moves dominated markets over the month. Fed-cut probabilities swung materially — falling to the mid-20s% intra-month before recovering to around an 80%+ probability by month-end — driving a bout of volatility across markets. After that two-way move, US Treasuries stabilised and the 10-year yield ended the month modestly lower, closing near 4.01% (down about 6bps on the month).

EM monetary policy stayed broadly supportive overall, but with regional differentiation. Asian and CEEMEA central banks were largely on hold. In LatAm, Banxico delivered a 25bp cut to 7.25% while the Brazilian central bank remained at a restrictive stance (Selic at 15%).

Political and geopolitical developments remained fluid, while sovereign credit trends continued to improve. The US draft peace framework for Ukraine revealed gaps with Russian, Ukrainian and European positions, making a near-term settlement unlikely. In idiosyncratic stories, S&P upgraded Ghana to B-, affirmed Qatar at AA with a stable outlook and shifted Uganda to a positive outlook.

Flows and performance stayed supportive, underpinned by improving technicals. Per JP Morgan data, YTD flows into retail EM Bond Funds are now at +\$25.2bn. EM hard-currency sovereign debt (JP Morgan EMBI Global Diversified Index) returned 2.13% in November and 13.02% YTD, EM local-currency debt (JP Morgan GBI-EM Global Diversified Index) returned 0.46% in November and 15.94% YTD and EM corporates (JP Morgan CEMBI Broad Diversified Index) returned 0.56% in November and 7.95% YTD.

Part II: Green Bonds

We have now completed the investment period of the fund, and are fully invested in EM Green Bonds. During the Run-off period, net income and divestment proceeds will be distributed to shareholders according to the terms of their share class.

Part III: Performance and Outlook

The net performance denominated in USD for the senior share class was 0.29%, and for the junior share class 1.09% over the month of November.

We retain a positive outlook on EM debt markets as the worst of global trade tensions are largely behind us, and we do not expect a meaningful impact from the US government shutdown to growth. Tariff increases of around 18% will weigh on US growth and consumption, but the impact should be offset by further fiscal policy support and further Fed rate cuts through 2026. Furthermore, corporate earnings remain strong, Artificial Intelligence and capex spending are supportive for activity and productivity gains. Given current market conditions, the asset class can continue to deliver mid-high single digit returns, supported by the resumption of inflows, record levels of money-market liquidity and lower US rates. Emerging markets will remain the biggest driver of global growth in 2026, led by Asian countries like India and China, where activity is supported by stimulus measures and exports. Other countries also retain some flexibility to offset tariffs through monetary and/or fiscal stimulus. Some have also pursued IMF programs and/or debt restructuring subject to adherence to structural reform measures.

EM corporate fundamentals remain solid. There are a few localised high-yield idiosyncratic stories in development, but these are not affecting the general market sentiment. Technical remain in robust shape with flows continuing into EM and the primary markets are open and active helping corporates to extend maturity profiles. We expect the HY default rates to stay low, below 3% this year vs its long-term average of 4.4%. As of end October, the rate for the broad EM HY market stood at 2.4%, according to JP Morgan. After heightened 2021-2023 defaults levels, the rates moderated last year and continue to come off.

Our base case remains a 'Goldilocks' environment where carry is likely to be sustained. Although we expect US growth to be resilient, it will slow below trend along with job growth, enabling further interest rate cuts from the US Federal Reserve. The pass-through from tariffs thus far has been modest, although a resurgence in US trade tensions is a risk to our outlook. Other concerns include renewed potential geopolitical tensions in the Middle East or a lack of concrete progress in the conflict opposing Ukraine and Russia.

Combining this with relatively tight valuations, we do not expect an "easy ride" for the remainder of the year and are focusing our research efforts on identifying quality and idiosyncratic stories to generate alpha.

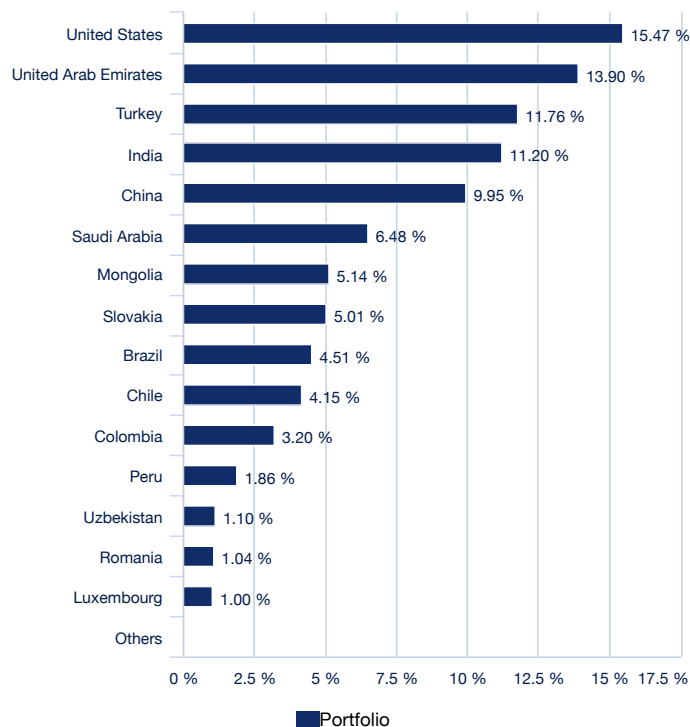

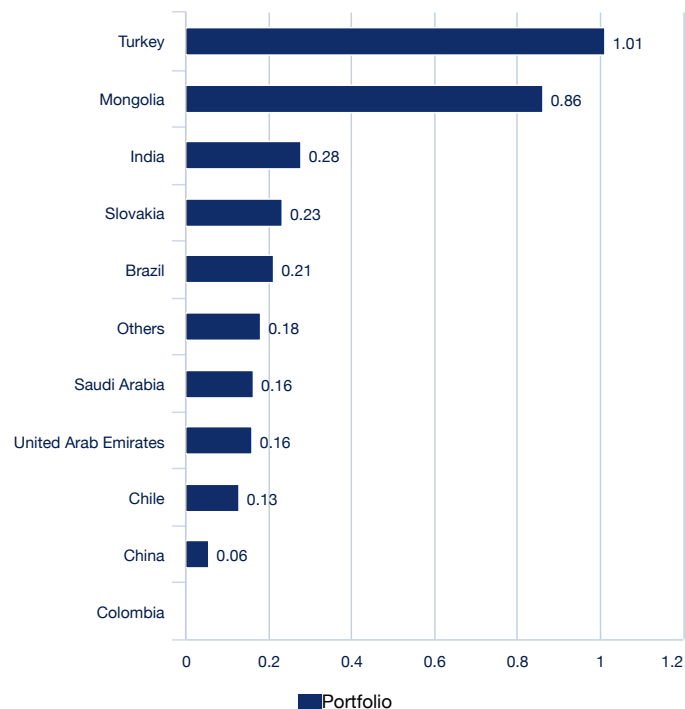

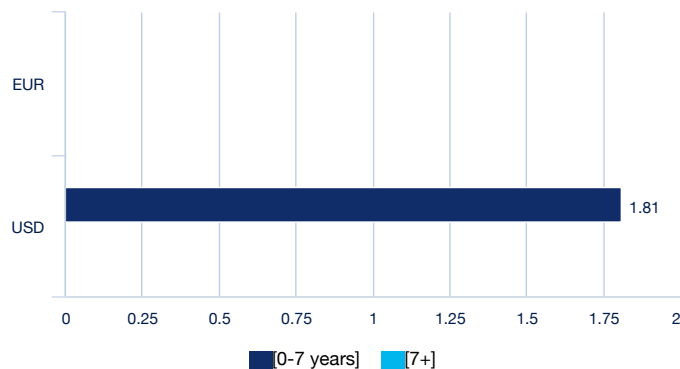
Spread Weighted Modified Duration (SWMD) (% , source: Amundi) *

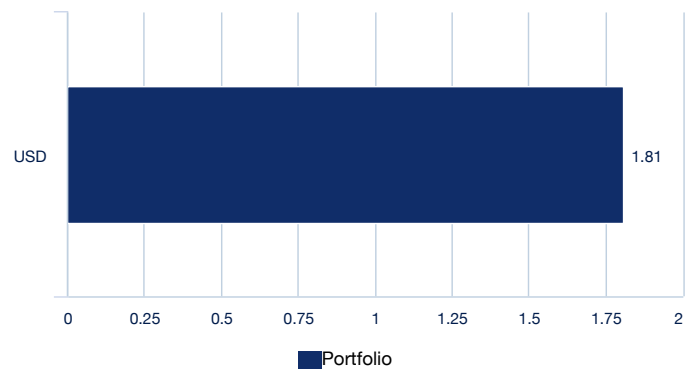
Global risk allocation per yield curve segment (Source: Amundi)

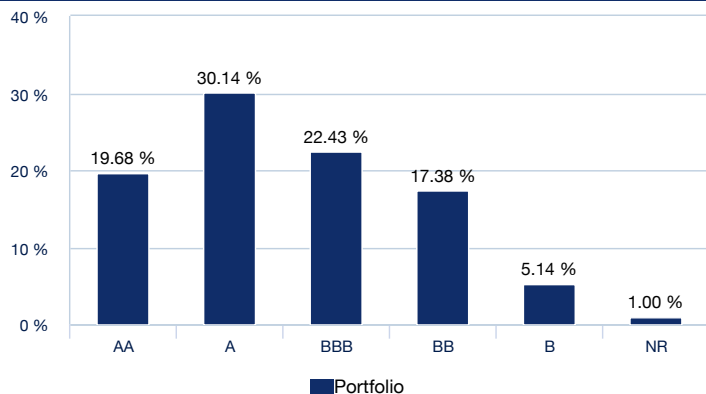


Global risk allocation per yield curve (Source: Amundi)

Portfolio breakdown by credit rating (Source: Amundi)



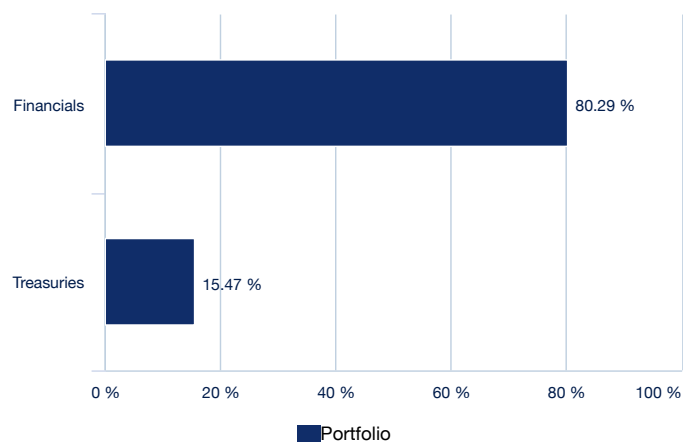

Green/Sustainable/Social Bonds breakdown

Green bonds are fixed income instruments for which the proceeds are specifically designated for projects with clearly defined environmental benefits. Eligible projects include, but are not limited to, renewable energy, energy efficiency (including efficient buildings), sustainable waste management, sustainable land use, biodiversity conservation, clean transportation and clean water. 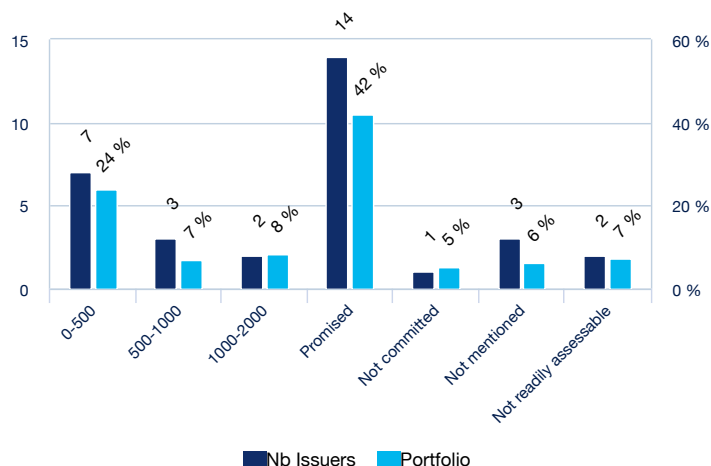

Breakdown of avoided emissions per bond



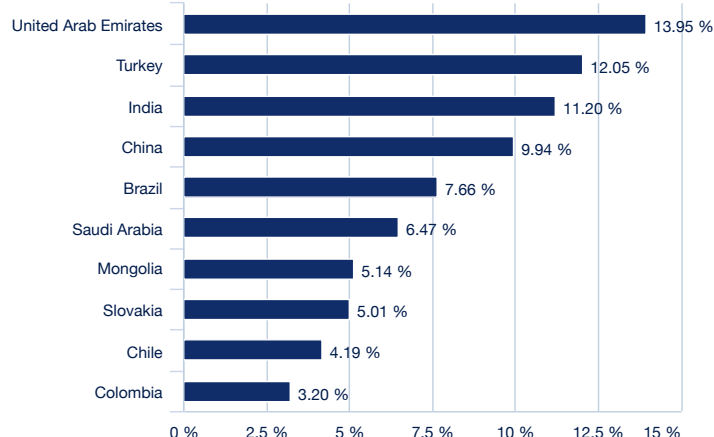

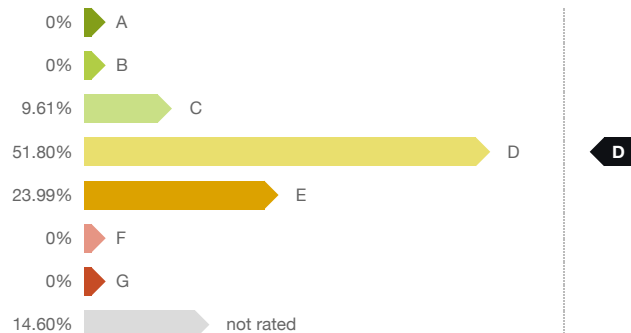
GSSS Bond Portfolio Top 10 countries



GSSS Bond Portfolio Top 10 Issuers

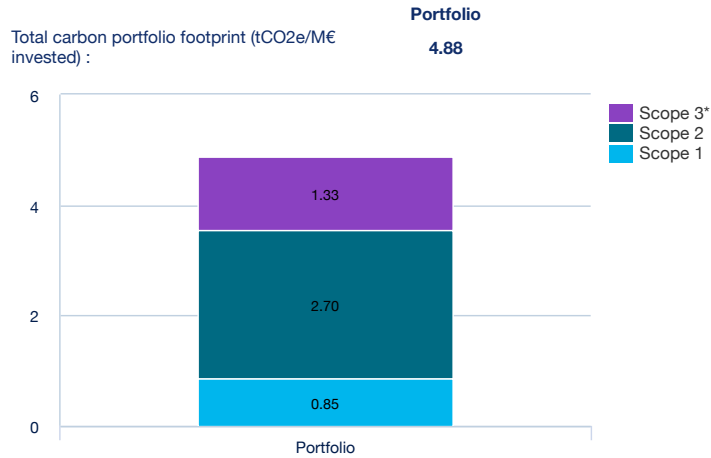

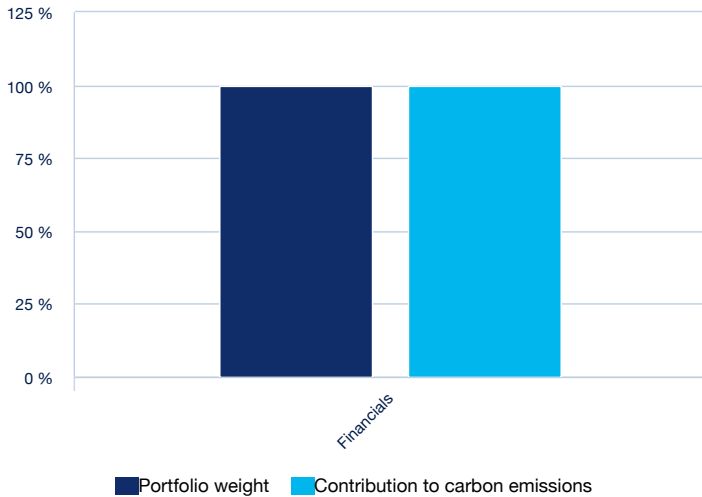
Carbon footprint: carbon emissions per euro million invested

Sectoral contribution to carbon emission



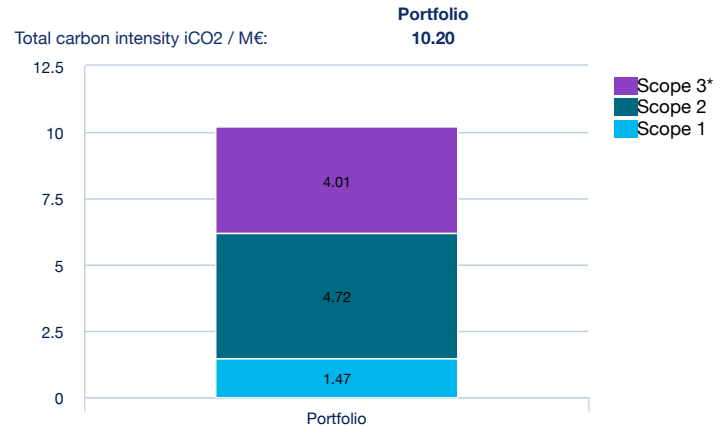
This chart compares the weight of each sector relative to its contribution to the portfolio's carbon emissions.

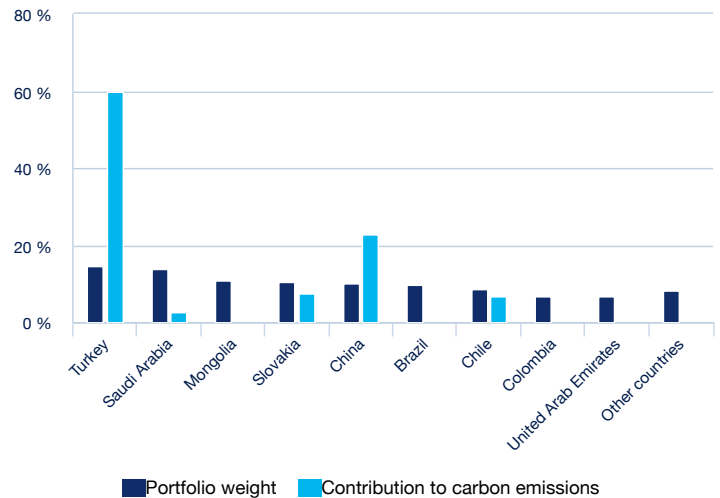

Definition of scopes:

- **Scope 1** : all emissions that arise directly from sources that are owned or controlled by the company.
- **Scope 2** : all indirect emissions generated by the purchase or production of electricity, steam or heat.
- **Scope 3** :All other indirect emissions, upstream and downstream of the value chain. For reasons of data robustness, Amundi has chosen to use emissions from activities upstream of Scope 3 - Source: Trucost EEI-O model (input/output model extended to the Trucost environment).
