NOTICE TO SHAREHOLDERS OF AMUNDI STOXX EUROPE DEFENSE (the “Sub-Fund”)

Terms not specifically defined herein shall have the same meaning as in the articles of incorporation (the “**Articles**”) and in the latest prospectus of the Company (the “**Prospectus**”).

Dear Shareholder,

We inform you that, due to a technical error during the issuance of the Prospectus dated “March 2026”, the expected and maximum levels of securities lending transactions which the Sub-Fund may enter into have been deleted from the Appendix “USE OF SECURITIES FINANCING TRANSACTIONS AND TOTAL RETURN SWAPS” in the Prospectus.

As indicated in the Key Information Documents of the Sub-Fund, in order to generate additional income to offset its costs, the Sub-Fund is able to enter into such securities lending operations.

The board of directors of the Company (the “**Board**”) has therefore decided to reinsert the previous levels of securities lending transactions applicable to the Sub-Fund in the Prospectus (the “**Correction**”), as further described in the table below:

This Correction has no impact on the investment objective or the investment strategy of the Sub-Fund and will be reflected in the next e-identified Prospectus.
