

## KEY INVESTOR INFORMATION

This document provides you with key investor information about this fund. It is not marketing material. ISIN: IE00BMBSC882 - A sub-fund of the Irish collective asset-management vehicle named Lyxor Newcits IRL III ICAV (the "ICAV") domiciled in Ireland. Managed by Amundi Asset Management, a subsidiary of Amundi Group

## Objectives and investment policy

The Fund is an active UCITS and is not managed in reference to a benchmark.

The Fund's investment objective is to seek capital appreciation over the medium to long term while simultaneously taking into account environmental, social, and governance objectives by being predominantly exposed to securities which meet the Investment Manager's criteria on sustainability which are reviewed and applied on an ongoing basis.

The Fund is actively managed and seeks to achieve this objective by investing predominantly on a long basis and may from time engage in short positions for hedging and/or portfolio construction purposes only.

Investment decisions will be made by implementing the Investment Manager's proprietary investment strategy, which is a disciplined, fundamental and systematic investment strategy grounded on the belief that the return of asset classes is driven primarily by changing macroeconomic factors and their influence on markets. Considering market conditions, the Investment Manager anticipates that the long-term volatility (measured as annualized standard deviation of monthly returns) of the Fund might be of approximately 8%.

The Fund will pursue such financial objective while taking into account environmental, social, and governance objectives by maintaining exposure primarily to securities aligned with the United Nations Sustainable Development Goals (SDGs) which are a set of global goals oriented toward positive Environmental, Social and Governance impact.

The Investment Manager has developed a proprietary methodology in order to determine the extent to which a security is aligned with the SDGs. Within each asset class, the securities that have the highest level of alignment with the SDGs are kept to constitute a universe of sustainable securities irrespectively of their business sector (also called a "best-in-universe" approach).

The main limits of the extra-financial approach of the Fund are third party data reliance and sustainability risk mitigation completeness. Further details about those limits can be found in the supplement for the Fund.

The share currency is the US Dollar (USD).

- **Invested financial instruments:** Equity securities, debt instruments, inflation linked bonds, exchange traded commodities, units of ETFs and money-market funds and FDIs such as futures, forwards, interest rates swaps, CDS, inflation swaps, total return swaps.
- **Dividend policy:** all the Fund's amounts available for distribution (if any) shall not be distributed to Shareholders, but reinvested.
- **Net Asset Value:** is calculated daily provided that the relevant stock exchanges are open for trading and orders can be covered.
- **Redemptions:** 1 p.m. Irish time, one open day before the Valuation Day or such other time as the Directors may determine and notify to Shareholders in advance.

## Risk and reward profile



The risk-return category shown above is based on the maximum level of risk that the Fund manager may take while adhering to the Fund's strategy, as well as on its performance, where applicable. This risk estimate may therefore not represent a reliable indicator of future risk, and may be subject to change over time. The lowest category does not mean risk free investment.

The Fund has been classified within category 4. Category 4 indicates that under normal market conditions a moderate loss of capital is possible ; the value of your investment may have moderate and low daily upside or downside variation.

Main risks not covered by the above indicator which could lead to a decrease in the net asset value of the Fund and which the Fund is authorized to disclose in this document (for more details about risks, please refer to the Risk Profile section of the prospectus):

- **Counterparty risk:** The Fund is exposed to the risk that any counterparty with which it has concluded an agreement or a transaction could become insolvent or otherwise default and more particularly when it has concluded financial derivative instruments over-the-counter or securities lending transactions. If such an event occurs, the net asset value of the Fund may decrease significantly. According to the regulation applicable to the Fund, such risk cannot exceed 10% of the Fund's total assets per counterparty.
- **Risk of Financial derivative Instruments:** The Fund invests in financial derivative instruments. These financial derivative instruments can induce different types of risks such as (but not limited to) leverage risk, high volatility risk, valuation risk or liquidity risk. If this risk occurs, the net asset value of the Fund may decrease significantly.
- **Operational risk:** In the event of an operational failure of the management company or one of its representatives, investors could experience loss, delay in processing subscriptions, conversions, redemptions orders or other type of disruptions.
- **Liquidity risk:** In certain circumstances, for example in case of low trading volume on financial markets, any buy or sale trade on financial instruments held by the Fund or having an impact on its value may lead to important variations of their valuations. In such circumstances, the net asset value of the Fund could be negatively affected.
- **Credit risk:** The Fund is subject to the risk that any issuer could become insolvent or to otherwise event having an impact on the credit quality of this issuer. The consequence of this risk or event may result in a decrease of the net asset value of the Fund.

The charges you pay are used to pay the costs of running the Fund including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
