Objectives and Investment Policy

To achieve a positive return in any type of market condition (absolute return strategy).

The Sub-Fund invests in debt instruments of any issuer. The Sub-Fund's exposure to MBSs and ABSs is limited to 20% of net assets.

The Sub-Fund makes extensive use of derivatives to reduce various risks, for efficient portfolio management and as a way to gain exposure (long or short) to various assets, markets or other investment opportunities (including derivatives which focus on credit, interest rates, foreign exchange and volatility).

Benchmark : The Sub-Fund is actively managed and seeks to outperform (after applicable fees) the Euro Short Term Rate Index (ESTER) (the "Benchmark") over the recommended holding period, while offering controlled risk exposure. The Sub-Fund may use a benchmark a posteriori as an indicator for assessing the Sub-Fund's performance and, as regards the performance fee benchmark used by relevant share classes, for calculating the performance fees. There are no constraints relative to any such Benchmark restraining portfolio construction. For indicative purposes, given the risk profile, the return is expected to be in excess (before applicable fees) of EONIA +1% per annum.

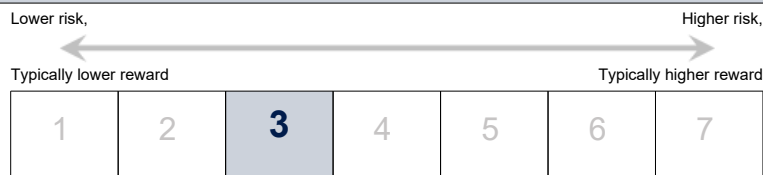
Management Process : The Sub-Fund integrates Sustainability Factors in its investment process as outlined in more detail in section "Sustainable Investment" of the Prospectus. The investment team uses a wide range of strategic and tactical positions, including arbitrage among volatility, credit, interest rate and currency markets, in assembling a highly diversified portfolio.

The accumulation share automatically retains, and re-invests, all attributable income within the Sub-Fund; thereby accumulating value in the price of the accumulation shares.

The minimum recommended holding term is 1 year.

Shares may be sold or redeemed (and/or converted) on any dealing day (except otherwise stated in the prospectus) at the respective dealing price (net asset value) in accordance with the articles of incorporation. Further details are provided in the prospectus of the UCITS.

Risk and Reward Profile



The risk level of this Sub-Fund mainly reflects the investment long and short positions taken in the fixed-income and foreign exchange markets within the pre-defined leeway.

Important risks materially relevant to the Sub-Fund which are not adequately captured by the indicator:

- Credit risk: represents the risks associated with an issuer's sudden downgrading of its signature's quality or its default.

- Liquidity risk: in case of low trading volume on financial markets, any buy or sell trade on these markets may lead to important market variations/fluctuations that may impact your portfolio valuation.
- Counterparty risk: represents the risk of default of a market participant to fulfil its contractual obligations vis-à-vis your portfolio.
- Operational risk: this is the risk of default or error within the different service providers involved in managing and valuing your portfolio.
- Emerging Markets risk : Some of the countries invested in may carry higher political, legal, economic and liquidity risks than investments in more developed countries.

Charges

The charges you pay are used to pay the costs of running the Sub-Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

One-off charges taken before or after you invest

Entry charge 2.50%

This is the maximum that might be taken out of your money before the proceeds of your investment are paid out.

Performance fee 15.00% a year of any returns the Sub-Fund achieves above Euro short-term rate (€STR).

No commission was taken over the last accounting year of the Sub-Fund.

The **entry** and **conversion charges** shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.

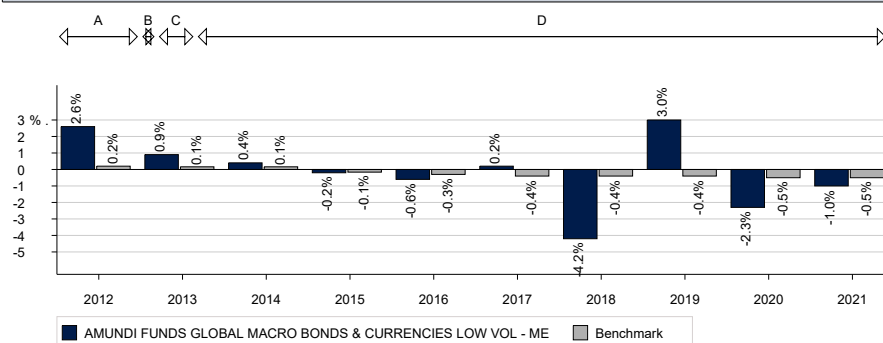
The **ongoing charges** figure is based on expenses for the year ending June 30, 2021.

This figure may vary from year to year. It excludes:

Past Performance



A : Since the launch of the sub-fund and until the end of this period, the objective of the Sub-Fund was to outperform the EONIA reference indicator in excess of 1%.

B : As from the beginning of this period, the objective of this Sub-Fund is to outperform the daily compounded EONIA after taking into account charges.

C : As from the beginning of this period, the sub-fund uses a new risk methodology and is managed based on a larger scope of eligible assets.

D : As from the beginning of this period, the ex post volatility of the sub-fund should be between 1% and 2% (instead of 1,20% maximum).
