Objectives and Investment Policy

This Sub-Fund is passively managed.

The objective of this Sub-Fund is to track the performance of Scientific Beta Developed Multi-Beta Multi-Strategy Four-Factor ERC Index, and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. The Sub-Fund aims to achieve a level of tracking error of the Sub-Fund and its index that will not normally exceed 1%

The Index is a Net Total Return Index : dividends net of tax paid by the index constituents are included in the Index return.

Scientific Beta Developed Multi-Beta Multi-Strategy Four-Factor ERC Index is an equity index made of equities from the universe of mid and large-cap markets of developed countries. Its objective is to generate a higher return than the universe of large and mid-cap developed market equities (Global universe) weighted by market capitalisation. The index applies several security selection filters to this Global Universe and several weighting systems to obtain a composition aiming to achieve this objective.

The exposure to the Index will be achieved through a Direct Replication, mainly by making direct investments in transferable securities and/or other eligible assets representing the Index constituents in a proportion extremely close to their proportion in the index.


The Investment Manager will be able to use derivatives in order to deal with inflows and outflows and also if it allows a better exposition to an Index constituent. In order to generate additional income to offset its costs, the Sub-Fund may also enter into securities lending operations.

Dividend Policy: the accumulation share automatically retains, and re-invests, all attributable income within the Sub-Fund; thereby accumulating value in the price of the accumulation shares.

The minimum recommended holding term is 5 years.

Shares may be sold or redeemed (and/or converted) on any dealing day (except otherwise stated in the prospectus) at the respective dealing price (net asset value) in accordance with the articles of incorporation. Further details are provided in the prospectus of the UCITS.


The **ongoing charges** figure is based on expenses for the current year. This figure may vary from year to year. It excludes:
