## **Objectives and Investment Policy**

The objective of this Sub-Fund is to achieve income, with a secondary objective of capital appreciation over the recommended holding period by investing in a diversified portfolio of (i) debt and debt-related instruments issued by both governmental and non-governmental issuers worldwide, which may be Investment Grade or sub-Investment Grade securities; (ii) equity and equity-linked instruments issued by any companies worldwide which offer higher than average dividend prospects; (iii) euro denominated Money Market Instruments and cash.

The Sub-Fund may invest in financial derivative instruments (including credit default swaps and total return swaps) to gain exposure to loans. The global exposure of the Sub-Fund to loans and loan indices will be limited to 20% of its net assets. The Sub-Fund may invest in Emerging Markets securities. The Sub-Fund may also invest in units or shares of UCIs. To enhance the yield of the portfolio and generate additional income, the Sub-Fund may sell short dated call options on selective equities held by the Sub-Fund. The Sub-Fund may also sell call options on equity indices as well as put options on equities to be bought in the future, at target prices that are below the current market level. The Sub-Fund will make material use of these income-enhancing strategies. The Sub-Fund will aim to achieve a broad diversification until Maturity Date. Benchmark : The fund is actively managed and is not managed in reference to a benchmark.

Management Process : The Sub-Fund integrates Sustainability Factors in its investment process and takes into account principal adverse impacts of investment decisions on Sustainability Factors as outlined in more detail in section "Sustainable Investment" of the Prospectus.

Investment Grade means a debt or debt-related instrument which, at the date of purchase, has a Standard & Poor's rating which is equal to or higher than BBB- or the equivalent rating by any other internationally recognised statistical rating organisation or, if unrated, is deemed to be of comparable quality by the Investment Manager.

The initial subscription period of the Sub-Fund will end on 27th September 2018. The Sub-Fund matures on 28th September 2023 (the "Maturity Date").

After the Maturity Date the objective of the Sub-Fund is to provide income and moderate capital appreciation over the medium term by investing in a diversified portfolio of Money market instruments and debt and debt related instruments issued by both governmental and nongovernmental issuers worldwide including Emerging Markets securities up to 15%.

The distribution unit pays dividends annually. Investors may sell on demand fortnightly on the 15th (or the next following business day if the 15th is not a business day) or the last business day of each calendar month.

The minimum recommended holding term is 5 years.

Investors may sell on demand on any business day in Luxembourg.



The comparison of the net assets of the unit and the performance hurdle (as defined in the prospectus) is carried out over a performance period from the Launch Date (as defined in the prospectus) to the Maturity Date. The performance fee represents 15% of the outperformance of the unit over its performance hurdle performance performance hurdle declines, the positive performance of the unit during the performance period. Where the return of the unit is negative over the performance period, no performance fee is paid.

Performance fee accruals will be paid to the Management Company at Maturity Date.
