### Objectives and Investment Policy

The Sub-Fund is a financial product that promotes ESG characteristics pursuant to Article 8 of the Disclosure Regulation.

To provide long-term growth of capital through an investment process that systematically includes ESG considerations.

The sub-fund invests at least 80% of its net assets in U.S. equity securities of U.S. companies. The sub-fund focuses on stocks of large capitalisation companies, but the sub-fund may invest in companies of any size.

The sub-fund may invest a maximum of 20% of its net assets in other securities than those described above, including equity-linked notes and convertible bonds issued by U.S. companies. In the same maximum limit, the sub-fund may invest in common stocks, preferred stocks, equity-linked notes, convertible bonds and other equity-linked instruments issued by non-U.S. companies traded on non-U.S. exchanges and certain eligible China A-shares via the Shanghai-Hong Kong Stock Connect and the Shenzhen-Hong Kong Stock Connect.

The sub-fund may also invest up to 20% of its net assets in each ADR/GDR and REITS.

The sub-fund may use derivatives for hedging purposes.

**Benchmark :** S&P 500 Index

The sub-fund is actively managed. The sub-fund may use the benchmark a posteriori as an indicator for assessing the sub-fund's performance. There are no constraints in relation to any such benchmark restraining portfolio construction.

**Management Process :** The Sub-Fund integrates Sustainability Factors in its investment process as outlined in more detail in section "Sustainable Investment" of the Prospectus. The sub-fund is actively managed and normally invests across a wide range of sectors and industries. The investment manager employs a growth style of equity management that emphasises companies with sustainable competitive advantages, long-term structural growth drivers, attractive cash flow returns on invested capital, and management teams focused on creating long-term shareholder value.

As a key component of the sub-fund's investment process, the investment manager conducts a non-financial analysis on at least 90% of the sub-fund's net assets on an ongoing basis.

The investment manager selects securities based on its conviction through a proprietary seven-step research framework structured around three key criteria: quality, growth and valuation. ESG considerations are integrated at each step of the investment manager's process.

The investment manager excludes direct investments in issuers (i) deriving any portion of their total revenue from the production or distribution of thermal coal, cluster munitions, biological weapons, chemical weapons and (ii) deriving any portion of their total revenue from the production of and more than 20% of their total revenue from the distribution of tobacco products and civilian firearms.

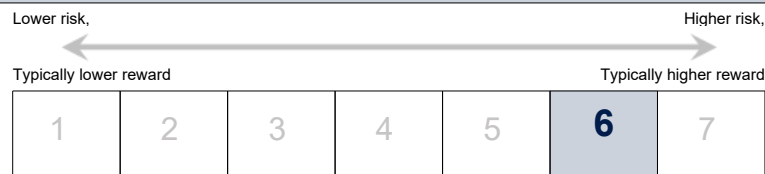

The accumulation share automatically retains, and re-invests, all attributable income within the Sub-Fund; thereby accumulating value in the price of the accumulation shares.

The minimum recommended holding term is 5 years.

Shares may be sold or redeemed (and/or converted) on any dealing day (except otherwise stated in the prospectus) at the respective dealing price (net asset value) in accordance with the articles of incorporation. Further details are provided in the prospectus of the UCITS.
