# **Objectives and Investment Policy**

The Sub-Fund is a financial product that promotes ESG characteristics pursuant to Article 8 of the Disclosure Regulation.

To provide long-term capital growth by investing in a concentrated portfolio of US companies. The sub-fund aims to outperform its benchmark over a full market cycle (three to five years).

The sub-fund will mainly invest in equities of companies that are based in, or do most of their business, in the United States of America. The sub-fund may also invest up to 20% in ADR/GDR and up to 10% in closed-ended REITS. The sub-fund may invest up to 10% of its assets in units/shares of UCITS.

The sub-fund may use derivatives for hedging purposes only.

**Benchmark**: S&P 500 Index (Total return net of 30% withholding tax). The sub-fund is actively managed by reference to and seeks to outperform the benchmark. The sub-fund is mainly exposed to the issuers of the benchmark, however, the management of the sub-fund is discretionary, and will be exposed to issuers not included in the benchmark. The sub-fund monitors risk exposure in relation to the Benchmark however the extent of deviation from the benchmark is expected to be significant.

Management Process: The Sub-Fund integrates Sustainability Factors in its investment process as outlined in more detail in section "Sustainable Investment" of the Prospectus. The investment manager utilizes a fundamental bottom-up security selection process to build a concentrated and high conviction portfolio that seeks to identify the most attractive investment ideas across the value and growth investment universes.

At least 51% of assets are invested in companies with positive environmental and/or social characteristics that follow good governance practices as measured through the Investment Manager's proprietary ESG scoring methodology and/or third party data. The Investment Manager evaluates and applies values and norms based screening to implement exclusions. To support this screening, it relies on third party provider(s) who identify an issuer's participation in or the revenue which they derive from activities that are inconsistent with the values and norms based screens. The list of screens applied that may result in exclusions can be found on the Investment Manager's Website at: https://am.jpmorgan.com/lu/en/asset-management/adv/investment-themes/sustainable-investing/understanding-SFDR/#. The sub-fund systematically includes ESG analysis in its investment decisions on at least 90% of securities purchased.

The accumulation share automatically retains, and re-invests, all attributable income within the Sub-Fund; thereby accumulating value in the price of the accumulation shares. The minimum recommended holding term is 5 years.

Shares may be sold or redeemed (and/or converted) on any dealing day (except otherwise stated in the prospectus) at the respective dealing price (net asset value) in accordance with the articles of incorporation. Further details are provided in the prospectus of the UCITS.
