The board of directors of the Company (the "**Board**") hereby informs the Shareholders that the index administrator Bloomberg Index Services Limited (BISL) has decided to make the changes detailed below in the (i) denomination and (i) methodology of the index "Bloomberg MSCI Euro Corporate Paris Aligned Green Tilted Index" (the "**Index**") tracked by the Sub-Fund.

**(i) Change of denomination of the Index**

**(ii) Change in the methodology of the Index**

The Sub-Fund's pre-contractual disclosures have been modified to reflect that the weight of the green bonds of the Index must, as from the 1<sup>st</sup> August 2025, be at least equal to that of the Parent Index.

These changes will be reflected in the next approved Prospectus.

Following the implementation of the changes, the Prospectus and the Key Information Documents of the relevant sub-funds will be amended accordingly.
